EDITORIAL NOTES

In this second issue of CANADIAN JEWISH ARCHIVES we continue the publication of transcripts of historical material relating to the early history of the Jewish community in Canada.

All of the nine items which appear in this issue are manuscript letters and documents in the National Archives of the Canadian Jewish Congress and are more than one hundred years old, some dating as far back as 1797; and all form part of the Martin Wolff Collection.

Of particular interest are the documents dealing with the purchase of the site for the first Jewish cemetery in Canada by David David in 1797 in Montreal, situated on part of the land now occupied by Dominion Square.

As in our first issue, no attempt has been made to modernize or correct the spelling or punctuation as given in the original letters and documents, and no comment is made except for an occasional explanatory note where necessary.

In addition to the transcripts we have included facsimile reproductions of the memorandum of 1798 regarding the purchase and fencing of the first Jewish cemetery in Montreal, and the letter of December 13, 1838 from Abraham Hart of London to Benjamin Hart of Montreal, outlining the difficulty of securing a Hazan from London for the Montreal congregation.

In this issue we also commence the publication of a list of accessions to the National Archives of the Canadian Jewish Congress.

Manuscript memorandum containing offer of land by David David for use as burial ground for Spanish & Portuguese Congregation in Montreal, dated February, 1798. FIS. L.

Summary in English of preceding document.

Deed of Sale dated August 31st, 1797 by Charles Joseph Ecuier, priest of the Parish of Repentiony, on his own behalf and on behalf of the other heirs of the Ecuier estate, to David David, merchant of the City of Montreal, to a lot situated in the suburb of St. Antoine, with a frontage of thirty-two feet, and four and a half arpents in depth for the sum of three hundred and ninety six pounds, the said lot to serve in perpetuity as a cemetery for individuals of the Jewish faith who may die in the Montreal district, for the entire Congregation, and for no other purpose, on condition that the said David David and his family shall have the perpetual direction and superintendence.

2. MANUSCRIPT RECORD DATED FEBRUARY 1796, REGARDING THE PURCHASE
AND FENCING OF A LOT BY DAVID DAVID, TO BE USED AS A BURYING GROUND
FOR THE JEWISH CONGREGATION OF LOWER CANADA.

SKETCH PAPER TO D. DAVID RE BURYING PLACE, FEBRUARY, 1798.

This paper belongs to me.

A.H. David.

Mr. D. David of the Town of Montreal, having very candidly come forward in offering to have fenced under his direction a Lot ground he has purchased for the Sole use and property of a Burying ground (Bethayim) for the present Jewish Congregation and as well as their Progeny.

The following is offered as a plan towards having the said Lot properly secured.

- 1st. The present Congregation for themselves and their future Progeny accept of the said Lot of Ground which-has-been kindly-purchased-by-Mr. David adjoining the old Burying Ground from the said Mr. D. David, the said lot being 36 feet long.
- 2nd. That the said lot be annexed to the former Burying ground forever as a Burying place and for that use only.
- 3rd. That Mr. D. David do make over by deed before a Notary the said Lot of Ground unto the Jewish Congregation of Lower Canada.
- 4th. That Mr. D. David be reimbursed the purchase money of the said Lot by a general Subscription.

- 6th. That Mr. D. David's offer of having the whole of said Lot as-well-as-the-eld-B properly secured by a good Stone wall or by 10 feet Cedar pickets as will be most proper be accepted, and that he be reimbursed same Also by a General Subscription.
- 7th. That this purchase Money of said Lot is Z16 the enclosing same in a secure manner will amount to Z20 wherefore the following Sums have been Subscribed by the Underwritten under the above stipulations.

As the whole now is with all and every the members and appurtenances thereto belonging, with which the purchasers are content and satisfied for having seen and viewed the same, and without any reservation of any part or portion of the aforesaid bargained and sold premises on the part of the Sellers who are lawfully seized thereof by virtue of a good and sufficient title as having acquired the same by inheritance. —

The aforesaid hereby bargained and sold Lot of ground and premises are depending and holding of the Seigniory of Montreal, and Subject to the payment of Such Cens et Rentes towards the Domain thereof, as may be legally due, but which the said parties cannot at present ascertain, the arrears of which Cens et Rentes shall be paid and discharged by the said sellers up to the day of these presents; And the said lot of ground is free and clear of every other charge, burthen and incumbrance as the said sellers now hereby declare; To Hold, Have, Use and Enjoy the aforesaid bargained and sold lot of ground and premises unto the said purchasers their Successors and assigns in their said capacity of Trustees forever by virtue of these presents; and to enter upon and take possession thereof immediately.

The present Sale is thus made subject to such seigniorial Rights as may in future arise and become due thereon and for the expreSs condition that the said purchasers their succeSsors in Office and Assigns, in order to preserve uniformity in the line of buildings, shall be bound to build in the same line and range of the present house of the said Francois Antoine LaRocque in the same street; and further for and in Consideration of the price and sum of Three Hundred and Fifty Pounds Current money of this province, which sum the said sellers do hereby acknowledge to have presently received from the said purchasers in their aforesaid capacity, and of which quit from this day forever.

In conversation with the Revd Isaac Leeser I learnd that the Congregation of your City has erected a New Synagogue, which would be consecrated next Summer and that you required a Hazan

The object now of my addresSing you, for which liberty I ask pardon, is to offer myself as a Candidate of that Situation. For six years I officiated in that Holy calling in Surinam and I have from that Congregation the strongest testimonials, as to capacity for the whole Routine of the Tebah Services, also that of Moel or Circumciser. I have also officiated in person on the holiday of and on two occasions, the entire Sabbath Prayers. I Can therefore add to the testimonials of the ParnasSim & members of the Portuguese and German Israelites and Contresigned and Sealed by the Major General Governour of Surinam, those of Mr. Leeser, the Parnas and Members of this Congregation.

My reason for leaving Surinam was the rect. of Letters from Philadelphia with Strong asSurances that the members of this congregation were anxious to make a Change, and that my pplication if on the Spot, would be crowned with Success. In this I was disappointed, and I now wait on you to ascertain if their is a prospect and what yearly compensation may be relied on

My views are moderate. I am accompanied with aged parents, being myself as yet young and unmarried

I have been always educated in the portuguese minhagh, and my pronunciation is free from any others.

The Revd Isaac Seixas of New York will add a few lines on the other Side respecting me, and in Conclusion I beg to remark that I can without delay prepare myself to visit your City, & be governed by the advice you may transmit to me.

is the only one in this Country over which there is a presiding Rabbi who although he is looked upon as the head of all the Jews here could in no-way be instrumental in procuring for you the Official required from a Portuguese Community. As a Reader such a person as you describe would be most desirable but I fear 'twould be a difficult matter to find him indeed. I am quite satisfied that were he to be met with twould not be necessary for him to go to America for a situation his services would be too eagerly sought on this side of the Atlantic. Unfortunately however there are but few among our people who take an interest in the promotion of their faith & those even (from the very fact of our Readers being looked upon rather as Servants to the Congregation than as Gentlemen holding the most honorable Situations therein) are not to be found among that Class of Society in which it is so much to be wished they should be. In the next place you could never expect that Five Hundred Dollars would be any inducement for a Man possessing the qualifications you require to leave his Home & Country to take upon himself the responsibility of that office & perform the various duties enumerated in your advice to me before alluded to. Since you in stating your inability to give a larger Sum at present express at same time a hope that in two or three years you will be enabled to increase his salary but this is a mere uncertainty, however under any circumstances I do not think from the enquiries I have made that you will succeed in procuring from the London Portuguese Community a competent person to administer in your Synagogue. I have not ventured to express an individual opinion but from the time I was first applied to by Mr. Benjamin Hart have consulted some of the leading members of that Congregation & endeavoured to gain all possible information on the subject & must Say from all I have learned have but poor hopes of being able to assist you in this respect. With regard to the Killer*I have not yet been able to make any enquiries but when I have anything to communicate I will do it through my Brother & so save you the unneceSsary expense of postage. I have since my return home applied to some of my Friends for contributions towards your funds but have not in a single instance done any good the complaint is that you have no Killer & so are not living as Jews consequently you have no claim upon them as such. I shall at all times be extremely happy to render you any assistance that lies in my power for the promotion of your views & remain with regard

- 2nd That I will Keep a school for the education of Jewish children without any charge, and attend them Four days in a week at least three hours each day.
- 3rd All offerings, fees, or emoluments, I may receive during the year, to be handed over to the Treasurer or any other Gentleman you may think fit, to be applied expressly to liquidate my outstanding debts.

Should the above meet with your approbation I trust nothing will be wanting on my part to give general satisfaction

Montreal, 3 June 1850

To the Trustees of the Montreal Cong. of Jews

Gentlemen

On Friday last, I could not obtain a piece of kosher beef -Mr. Sexton, the Eutcher informed me, Mendles had killed one kosher ox, that
he had but Half, his Partner having the other Half -- That he observed to
Mendles, "you state Foullom has no kosher Beef "one fore quarter will not be
sufficient, I have three more to Kill, Kill them" Answer "I have no time"
Sexton further states, when he first commenced to kill he informed Mendles his
Partner had Half of every Ox he Killed -- and that he considered it hard to
pay Mendles one dollar per week, and have no Beef to Sell -- Gentlemen if your
rules allow this charge, I consider it a hardship on the Congregation, unjust
and opressive, if this charge is made without your Knowledge it is on the part
of Mendles a Swindle, fraud and a disgraceful Imposition and will be most dishonourable on your part to suffer it -- I contend it is your duty to oblige
Mendles to return to your hands the four dollars for Four Weeks Killing at
Sexton's, and your return the sum to the butcher, If you encourage such dishonesty, what can you expect?

Last Fall I was shamefully insulted by Foullam and for six months obliged to purchase Treifer Beef for my Family, I was happy to find this Spring you had another Butcher for Cosher Beef -- after One Month, this is distributed by that infamous Mendles --

If after paying the Seat Money that I do -- I am to be deprived of this right, a right that I could claim in a Court of Justice -- to prevent Trouble I withdraw from the Congregation all together, Sorrowfull as it may be at My advanced Age --
